# What is the Ryan White **HIV/AIDS Program?**

The Ryan White HIV/AIDS Program (RWHAP) is named after Ryan White, who was 13 when he was diagnosed with AIDS after a blood transfusion in December 1984. Living in Kokomo, Indiana, doctors gave him six months to live. When Ryan tried to return to school, he faced AIDSrelated discrimination in his Indiana community. Along with his mother Jeanne White Ginder, he rallied for his right to attend school. He

gained national attention and became the face of public education about the disease. Surprising his doctors, Ryan lived five years longer than expected. He died in April 1990, one month before his high school graduation. Congress passed the Ryan White Comprehensive AIDS Resources Emergency (CARE) Act in August 1990, now called the Ryan White HIV/AIDS Program.



### WHAT IS THE AETC PROGRAM?

The AIDS Education and Training Center (AETC) Program is a national network of leading HIV experts who provide locally based, tailored education, clinical consultation, and technical assistance to healthcare professionals and organizations. The AETC Program's mission is to improve the quality of life for people with HIV (PWH) or vulnerable to HIV acquisition throughout the United States (U.S.), the District of Columbia, the Virgin Islands, Puerto Rico, and the U.S.-Affiliated Pacific Islands.

The AETC Program supports the goals of the National HIV/AIDS Strategy and the End the **HIV Epidemic in the United States** initiative by increasing the number of healthcare teams educated and motivated to care for PWH, and increasing access to care, thereby reducing HIVrelated health disparities.

The AETC Program is funded by the Health Resources and Services Administration (HRSA) HIV/AIDS Bureau (HAB), of the U.S. Department of Health and Human Services (HHS), under Part F of the RWHAP.

### **RWHAP Clinical Conference**

This annual conference provides updates on cutting-edge research, care, and treatment issues in the medical management of HIV infection for new and experienced HIV clinical decision makers in RWHAP-funded clinics.

The format is a mix of lectures, case-based interactive presentations, and small-group workshop breakout sessions.

## National Ryan White Conference (NRWC) on HIV Care & Treatment

Held every two years, the NRWC is hosted by HRSA HAB to deliver program and policy updates, share innovative models of care, and provide training and technical assistance to RWHAP recipients; federal, national, state, and local stakeholders; health care and service delivery providers; and PWH. This biennial event provides a forum to share best practices and innovative strategies that will help participants to continue to facilitate a coordinated national response to reduce new HIV infections and HIV-related health disparities, as well as improve the health outcomes of PWH in the U.S.

### WHAT DOES THE AETC PROGRAM DO?

As the clinical training arm of the RWHAP, the AETC Program collaboratively transforms HIV care by providing healthcare teams with continuing education, capacity-building support, technical assistance, and clinical consultations.

Healthcare professionals trained by the AETCs develop the confidence and competency to address HIV-related issues and are more willing than other primary care providers to treat PWH.

# **National HIV Curriculum**

The National HIV Curriculum is a free educational website from the University of Washington offering course modules like Basic HIV Primary Care, Antiretroviral Therapy, HIV Prevention, Co-Occurring Conditions, and Key Populations. The 37 lessons and corresponding question bank topics offer free CME, CNE, pharmacology CE, and CE. The in-depth antiretroviral medications section, mini-lectures, and 18 clinical screening tools and calculators support clinical decision-making.


# The National HIV Residency Pathway Consortium (NHRPC)

The **Ryan White HIV/AIDS Program** comprises five parts (A,B,C,D and F). Each part has a different funding purpose. Together, they help provide a critical safety net for people with HIV (PWH) in the United States (U.S.) and its territories.
